

## **CHEEZ-IT™ GLUTEN FREE GIVEAWAY**

### OFFICIAL RULES

NO PURCHASE NECESSARY. PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. **PROMOTION DESCRIPTION:** The **Cheez-It™ Gluten Free Giveaway** (the “**Sweepstakes**”) is a social media Sweepstakes that begins on 2/9/26 at 12:00:00 AM Eastern Time (“**ET**”) and ends on 2/12/26 at 11:59:59 PM (ET) (the “**Promotion Period**”).

Throughout the Promotion Period, eligible entrants will have the opportunity to “like” the Sweepstakes post by the **Cheez-It®** Instagram account (**@cheezit**) on 2/9/26; comment on it using the Hashtag and tag a friend (as defined below); and follow the **Cheez-It®** Instagram account (**@cheezit**) and the **Sweet Loren’s** Instagram account (**@sweetlorens**) on Instagram (the “**Submission**”), as more fully set forth below. There will be one (1) Grand Prize winner in the Sweepstakes that will be randomly selected at the conclusion of the Promotion Period

By participating in the Sweepstakes and completing a Submission (as more fully set forth below), each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of the Kellanova (“**Sponsor**”), which shall be final and binding in all respects.

2. **ELIGIBILITY:** Sweepstakes is open only to legal residents of the forty-eight (48) contiguous United States and District of Columbia and are eighteen (18) years of age or older at time of entry. - Submissions must be posted to a non-private social Instagram account; Instagram accounts can be obtained for free at <http://www.instagram.com>;

- Submission must comply with all of Instagram’s terms and conditions, as updated from time to time, as posted on its platform;

Sponsor shall have no liability for any winner notification that is lost, intercepted, or not received by the potential

winner for any reason.
